

MEMORANDUM OF UNDERSTANDING



Between the undersigned:

- International University Sports Federation (FISU)

Represented by Oleg Matytsin (President) and Eric Saintrond (Secretary General) acting in the name and on behalf of FISU

on one hand, and

- Centro Universitario Sportivo Italiano (CUSI)

Represented by Antonio Dima (President), acting in the name and on behalf of Centro Universitario Sportivo Italiano on the other hand,

Agree on the following:

Article 1 - OBJECT

Object of the Memorandum of Understanding:

- The target of the Memorandum of Understanding intends to promote the Healthy Campus programme by each National University Sports Federation among all the Universities and Institutions of Higher and Tertiary Education of each country.
- The FISU Healthy Campus programme is in line with the Sustainable Development Goals 2030 established by the United Nations, as well as the guidelines of the Kazan Action Plan (UNESCO), the Global Action Plan on Physical Activity 2018- 2030 (WHO) and the FISU Global Strategy 2027.

Article 2 - COMMITMENT OF THE PARTIES

The signatories to this Memorandum of Understanding agree with the strategic guidelines and actions:

2.1. Global priorities:

- Create a global community with healthy lifestyles and wellbeing on campuses
- Promote the values of physical activity and sport, health, environmental sustainability, and social responsibility
- Strengthen the relationship between FISU, CUSFs, NUSFs and Universities, Institutions of Higher and Tertiary Education.

2.2. Commitment of FISU:

- Promote and communicate the activities of Centro Universitario Sportivo Italiano under the Healthy Campus programme
- Develop a training programme in the context of Healthy Campus for Centro Universitario Sportivo Italiano and universities
- Offer a 50% fee discount in the second year of each Healthy Campus cycle for universities of Italy
- Grant the Centro Universitario Sportivo Italiano 200 EUR or each registration to ensure promotion and communication about Healthy Campus in Italy.

2.3. Commitment of CUSI:

- Promote the endorsement by at least one Italian Governmental or non-Governmental Organization to the Healthy Campus Programme, and together with Centro Universitario Sportivo Italiano communicate this recommendation as a national development factor for well-being in Higher Education Institutions of the Country
- Promote and communicate the Healthy Campus programme in higher education institutions in Italy
- Promote and participate in meetings between the CUSI, FISU and the governmental authority responsible for higher education (or health and physical activity and sport) in Italy to present the Healthy Campus programme
- Collaborate in the organisation of coaching sessions in the scope of Healthy Campus
- Report all activities developed in the domain of the Healthy Campus programme through an annual report to FISU.

Article 3 - ACTIVITY PLAN AND EVALUATION

3.1. Meetings

- FISU and Centro Universitario Sportivo Italiano meet at least once a year (virtual meeting or during a FISU event) to define the activity plan, the indicators to be achieved with the partnership, and to make the evaluation of the previous year.
